Tritech International Holdings Pte Ltd ("TI") was a controlling shareholder of Tritech Group Limited ("TGL") and was placed in voluntary liquidation on 28/08/2015. Wang Hong held an approximate 8.64% shareholding interest in TI and had received in proportion to her shareholding interest in TI, ordinary shares and warrants of TGL following an interim capital distribution by the Liquidator satisfied by an in-specie distribution. The shares have been credited into the respective shareholders' CDP accounts on 9/06/2016.

Pending the opening of a CDP account in Wang Hong's name and subsequent transfer to said CDP account, the 26,792,370 ordinary shares and 13,416,185 warrants of TGL are presently held in the CDP securities account of TI on behalf of Wang Hong, with TI acting as a bare trustee. Pursuant to s. 4(10)(a) of the Securities and Futures Act (Cap. 289) an interest in a security if the interest is that of a person who holds the security as a bare trustee is disregarded.
