

EFFECTIVE DATE FOR PROPOSED CHANGE OF COMPANY'S NAME AND CHANGE OF TRADING COUNTER NAME

1. INTRODUCTION

1.1. The Judicial Managers refers to Hatten Land Limited's (under judicial management) (the "**Company**"):

- (a) circular to Shareholder dated 30 June 2026 (the "**Circular**"); and
- (b) announcement dated 22 July 2026 in relation to the results of the extraordinary general meeting (the "**EGM**"), which, among other things, announced the approval of the proposed change of the Company's name (the "**Announcement**").

1.2. Unless otherwise defined herein or the context requires otherwise, all capitalised terms used in this announcement shall have the same meanings ascribed to them in the Circular and the Announcement.

2. CHANGE OF COMPANY'S NAME

2.1 Further to the EGM of the Company held on 22 July 2026, where the special resolution relating to the Proposed Change of Name was duly approved by the Shareholders, the Judicial Managers wishes to announce that the Notice of Special Resolution for the Proposed Change of Name has been lodged with the Accounting and Corporate Regulatory Authority of Singapore on 31 July 2026 and the name of the Company has been changed to "**Metrocon Holdings Limited**" with effect from 31 July 2026.

3. CHANGE OF COMPANY'S TRADING COUNTER NAME

3.1 The Company has arranged with SGX-ST to change its trading counter name from "*Hatten Land Limited*" to "*Metrocon Holdings Limited*" on Catalist Board. The change of the Company's trading counter name on the Catalist Board will take effect at 9.00 a.m. on Thursday, 6 August 2026. The new trading counter name will be "**Metrocon**" and the new trading code will be "**MTC**".

The shares in the Company have been suspended since 6 August 2024. Although the Company's shares are under suspension, shareholders and investors are advised to read this announcement and any past and future announcements by the Company carefully when dealing with the shares of the Company. Shareholders and investors should consult their stockbrokers, bank managers, solicitors or other professional advisors if they have any doubt about the actions they should take or when dealing with their shares in the Company.
