**Establishment of Premium Education Facilities in Thanlyin Star City** 

Yangon, Myanmar, 11 March 2014 - Yoma Strategic Holdings Ltd. (the "Company",

together with its subsidiaries, the "Group") plans to develop premium educational

facilities in the Thanlyin Township in areas adjacent to the Group's Star City development

area<sup>1</sup>. The Group is in discussion with an international education group to operate an

international school and a local education group to operate a private local school in that

area.

**International School** 

Agreement has been reached with Thanlyin Estate Development Limited ("TED"), a

company in which the Group holds a 70% economic interest, whereby a new international

school is targeted to be opened by August 2015 in an area adjacent to the Star City

development area<sup>1</sup> by Yoma Strategic and Education Index Management (EIM),

overseen by Dulwich College International with Dulwich College in London as

educational adviser.

The Company believes that the influx of expatriate families into the country is expected

to drive demand growth for high-quality international education while supply is currently

limited. Out of an estimated 8.5 million school-age children in Myanmar, only 3,200

students are enrolled in five (5) premium international schools<sup>2</sup>.

<sup>1</sup> The proposed sites for the international school and local school are not part of the existing land development rights in the Star City Project held by TED and are instead owned by the Serge Pun & Associates (Myanmar) Limited group of companies (the "SPA Group"). The Company is in concurrent preliminary discussions with the SPA Group in relation to the joint development of these areas for educational facilities whereby it is envisaged that the SPA Group will inject the land development rights in

these areas as its contribution to the joint development. Further announcements will be made as and when the parties have entered into definitive agreements after the conclusion of discussions.

the school buildings and facilities which will be leased to the local school.


