NON-BINDING MEMORANDUM OF UNDERSTANDING ON POSSIBLE COLLABORATION WITH IMPERIUM CROWN LIMITED

1. INTRODUCTION

2. INFORMATION OF THE MOU

2.1 Background

(费县奇石特色小镇发展有限公司), holds a 50-year operating right to Wonder Stone Park, located in a commercial precinct in Feixian county, Linyi city, Shandong province, PRC. ICL also owns a hotel situated within the Wonder Stone Park.

UnUsUaL Productions an experienced organizer of large-scale events such as international music festivals and mega concerts in Singapore and around the region, can assist in the design and layout for these coming large-scale events, by incorporating audio, video and lighting equipment.

2.2 Rationale for and the MOU

UnUsUaL continually seeks opportunities for the development and growth of its business and operations. The Directors believe that this collaboration complement some of the initiatives which are currently under development by the Group.
