SPACKMAN ENTERTAINMENT GROUP'S *MASTER* #1 AT KOREAN BOX OFFICE WITH HIGHEST DECEMBER OPENING IN HISTORY

- *MASTER*, a Korean crime-action film, opened top at Korean box office on the first day of its release with total ticket admissions of 416,680 as at 21 December 2016
- Film, which was released on 1,448 screens, marks the highest December opening in history of the Korean box office
- Grossed US\$2.6 million in box office revenue, representing a market share of 66.3%

Singapore, 22 December 2016 – Spackman Entertainment Group Limited (“**Spackman Entertainment Group**” or the “**Company**” and together with its subsidiaries, the “**Group**”), announced today that its crime-action film, *MASTER*, produced by its indirect wholly-owned subsidiary Zip Cinema Co., Ltd. (“**ZIP Cinema**”) opened #1 at the Korean box office on the first day of its wide release on 21 December 2016.

According to the latest statistics from the Korean Film Council, *MASTER* recorded total ticket admissions of 416,680 with gross box office revenue of US\$2.6 million (or KRW 3.2 billion) as of 21 December 2016¹. The film, which was released on 1,448 screens, captured 66.3% of the nation’s market share of box office revenue for that day. The ticket admissions and the number of opening screens for the first day of *MASTER* marks the highest December opening in the historical records of the Korean box office.

MASTER is slated to be screened in Singapore theatres around 12 January 2017.

The crime-action film is directed by Cho Ui-seok, who helmed the film *COLD EYES (2013)*, another ZIP Cinema production. *COLD EYES (2013)* was one of the top 10 films at the Korean box office in 2013, grossing a total of 5.5 million tickets.

MASTER features three of Korea’s top actors: Lee Byung-hun, Gang Dong-won and Kim Woo-bin. The film depicts the takedown of a charismatic swindler who committed a massive multi-billion dollar fraud.

Our films are theatrically distributed and released in Korea and overseas markets, as well as for subsequent post-theatrical worldwide release in other forms of media, including cable TV, broadcast TV, IPTV, video-on-demand, and home video/DVD, etc. We release all of our motion pictures into wide-theatrical exhibition initially in Korea, and then in overseas and ancillary markets.

We also operate a café-lounge called Upper West, in the Gangnam district of Seoul and own a professional photography studio, noon pictures Co., Ltd..

The Group is a strategic shareholder of Spackman Media Group Limited (“**SMGL**”). SMGL, a company incorporated in Hong Kong, together with its subsidiaries, collectively is the leading talent agency and entertainment content production company in Korea, managing over 50 artistes including some of the top names in the Korean entertainment industry. SMGL operates the talent management business through renowned agencies such as MS Team Entertainment Co., Ltd., Fiftyone K Inc., SBD Entertainment Inc., UL Entertainment Co., Ltd., and Kook Entertainment Co., Ltd.

On 30 December 2015, the Group announced a share swap agreement for the sale of its equity interest in its associated company, SMGPL, in consideration for 7,500,000 ordinary shares in the capital of Spackman Media Group Limited. On 16 May 2016, the Group announced the completion of the share swap.

On 14 September 2016, the Group announced the completion of its disposal of the Company's entire equity interest in its indirect wholly-owned subsidiary, Opus Pictures Limited Liability Company.
