UnUsUaL Retells Story of Apollo 11 Moon Landing, Schedules 3-Year Tour in North America from Mid-2019

SINGAPORE, 2 AUGUST 2018 – UnUsUaL Limited ("**UnUsUaL**", along with its subsidiaries, the "**Group**"), has entered into a binding Heads of Agreement ("**HOA**") with Nick Grace Management Ltd. ("**NGM**") to develop and produce *APOLLO*, a show that celebrates the 50th anniversary of man's first steps on the moon. UnUsUaL and NGM will form a joint venture company ("**JVCo**") under the HOA.

The CEO of UnUsUaL, Leslie Ong, commented, "We are incredibly honoured to form a rights-holding joint venture company with NGM, a proven team of show creators and producers, to develop and produce the show *APOLLO*. It marks our first foray into the North American live entertainment industry, and we are as excited about the larger market potential as we are humbled to learn with an established partner, about the dynamics and opportunities of a more mature industry. This is a very important milestone for us, and it is in line with our plans to move from event production and concert promotion, to ownership of globallyappealing shows and other forms of live entertainment IP."

Nick Grace, Managing Director of NGM also stated "We are telling the moon landing story in a purpose-built touring venue with state-of-the-art 360 degree video-projection and video-mapping that can transform from mission control to space itself. Working with UnUsUaL, we will educate young people and in doing so, inspire a new generation with an appreciation of the unique challenges and extraordinary achievements of the Apollo missions. This show will be an event, a destination, a once-in-a-lifetime theatrical experience, something that attracts young and old, families and school groups. The audience will leave with an understanding of why man went to the moon and why it is essential to continue the space programme today and in the future."

NGM is one of the producers of *APOLLO* alongside SWISSAPOLLO, Mat Churchill Productions Ltd and Anthony Van Laast MBE. NGM is currently producing *WALKING WITH DINOSAURS – The Arena Spectacular*, and is the Associate Producer of the MAMMA MIA! International & UK Tour. Other credits include international tours of THE LION KING, BATMAN LIVE, WICKED and BLUE MAN GROUP. UnUsUaL will lead this round of investment into the US\$13.5 million production of *APOLLO*, representing a consortium of



investors that include Sliding Doors Entertainment. The resulting JVCo will be a subsidiary of UnUsUaL, which accounts will be consolidated within the latter's books.

APOLLO is slated to start touring North America in the summer of 2019 to coincide with the 50th anniversary of the moon landing, and to run for a period of 3 years in various cities, after which it has plans to tour Southeast Asia, Australia, Europe, Middle East and Africa in the subsequent years.
