RECEIPT OF WRIT OF SUMMONS

The Board of Directors (the "Board") of Huationg Global Limited (the "Company" and together with its subsidiaries, the "Group") wishes to announce that on 1 February 2018, the Company and its whollyowned subsidiary, Huationg Contractor Pte. Ltd. ("Huationg Contractor") have been served with a writ of summons dated 30 January 2018, endorsed with a statement of claim dated 30 January 2018, filed by (i) Huationg Holdings Private Limited; (ii) Huationg Inland Transport Services Pte. Ltd.; (iii) Huationg (Asia) Pte. Ltd.; and (iv) Hua Resources Pte. Ltd. (the "Plaintiff Group") in the High Court of Singapore ("HC/S 96/2018") (the "Suit").

For the avoidance of doubt, the Plaintiff Group is not a part of the Group.

The Plaintiff Group alleges that (i) the Plaintiff Group is the co-owner of certain trademarks registered in the name of the Company and Huationg Contractor or alternatively that the said trademarks are invalid; and (ii) the Company and Huationg Contractor had made certain groundless threats of infringement and had defamed the Plaintiff Group, causing Huationg Holdings Private Limited and Huationg Inland Transport Services Pte. Ltd. to suffer damages.

The Company and Huationg Contractor are disputing the claims made by the Plaintiff Group and are in the process of seeking legal advice on this matter. The Company and Huationg Contractor intend to strenuously defend the allegations.

As at the date of this announcement, the Company does not expect the Suit to have a material impact on the Company's earnings per share and net tangible assets per share for the current financial year ending 31 December 2018.

The Company will make the relevant update announcements in compliance with the Singapore Exchange Securities Trading Limited ("SGX-ST") Listing Manual Section B: Rules of Catalist where there are developments on this matter.
