Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited (“**SGX-ST**”), Frasers Hospitality Asset Management Pte. Ltd., in its capacity as manager of Frasers Hospitality Real Estate Investment Trust (“**FH-REIT**”, and in such capacity, the “**Manager**”), wishes to announce that Perpetual (Asia) Limited, as trustee of FH-REIT has entered into the following loan facilities with the conditions (the “**Relevant Conditions**”) as set out below which make reference to a change in the manager of FH-REIT, or places restrictions on a change of control of the Manager.

<p>S\$370 million bank loan facilities comprising term loan facilities in the aggregate amount of S\$350 million and a revolving credit facility of S\$20 million between (i) Perpetual (Asia) Limited, (in its capacity as trustee of FH-REIT) (the “Borrower”), as borrower and (ii) DBS Bank Ltd., Malayan Banking Berhad, Singapore Branch and Bank of China Limited, Singapore Branch (the “Original Lenders”), as the original lenders, (the “Facility Agreement”).</p>	<ul style="list-style-type: none"> • It is an event of default if, without the prior written consent of all the Lenders (i) the Manager resigns or is removed as manager of FH-REIT and is not replaced by a substitute approved by the Monetary Authority of Singapore; or (ii) the Manager ceases to be a majority owned (directly or indirectly) Subsidiary (as defined in the Facility Agreement) of Frasers Property Limited. • It is a condition that the Manager shall at all times be a majority-owned (directly or indirectly) Subsidiary of Frasers Property Limited.

None of the events described under the Relevant Conditions has occurred and none of the conditions described under the Relevant Conditions has been breached. Assuming an event under the Relevant Conditions occurs, and a failure to prepay causes a cross default under other borrowings of FH-REIT, the aggregate level of facilities that may be affected is approximately S\$799.0 million (excluding interest and exclusive of the facilities which is the subject of this announcement) as at the date of this announcement. This does not take into account (i) the amount of the loan facilities which have not been, and which remain available for, drawdown and (ii) future notes issuances under the S\$1,000,000,000 multicurrency debt issuance programme of FH-REIT

Treasury Pte. Ltd. (a wholly-owned subsidiary of FH-REIT) and guaranteed by Perpetual (Asia) Limited (in its capacity as trustee of FH-REIT).
