CHANGE OF COMPANY NAME TO "9R LIMITED" AND CHANGE OF TRADING COUNTER NAMES

The board of directors (the "**Board**") of 9R Limited, formerly known as Viking Offshore and Marine Limited (the "**Company**"), refers to (i) the circular to shareholders dated 14 April 2022 in relation to, *inter alia*, the proposed change of name of the Company from "Viking Offshore and Marine Limited" to "9R Limited" (the "**Proposed Change Of Name**"); and (ii) the announcement of the Company on 6 May 2022 in relation to the results of the extraordinary general meeting of the Company held on 6 May 2022 (the "**EGM**").

Further to the EGM, where the special resolution relating to the Proposed Change of Name was duly passed, the Board wishes to announce that the Notice of Special Resolution for the Proposed Change of Name has been lodged with the Accounting and Corporate Regulatory Authority ("**ACRA**") on 15 July 2022 and ACRA has confirmed that the name of the Company has been changed to "9R Limited" with effect from 15 July 2022 by issuing the Certificate Confirming Incorporation of Company dated 15 July 2022 under the name of "9R Limited".

The Company has arranged with the Singapore Exchange Securities Trading Limited ("**SGX-ST**") to change its trading counter names for its shares and warrants on the Catalist of the SGX-ST with effect from 9.00 a.m. on 20 July 2022 and the new trading counter names of the Company for its shares and warrants will be as set out below. The Company's trading codes of "1Y1" and "KJZW" for the shares and warrants respectively remain unchanged.
