Pursuant to the exercise of its right of compulsory acquisition under Section 215(1) of the Companies Act, Chapter 50 of Singapore ("Compulsory Acquisition"), Forestt Investment Pte. Ltd. (the "Offeror") had on 8 June 2021 completed the Compulsory Acquisition of an aggregate of 1,519,504 issued and paid-up ordinary shares (the "Shares") in the capital of Neo Group Limited (the "Company") at a consideration of S\$0.60 in cash for each Share. Following the Compulsory Acquisition, the Offeror owns 147,350,959 Shares, representing 100% of the Shares in the Company.

Mr. Neo Kah Kiat ("Mr. Neo") is deemed to have an interest in the 147,350,959 Shares owned by the Offeror pursuant to Section 4 of the Securities and Futures Act, Chapter 289 of Singapore, as Mr. Neo is entitled to exercise or control the exercise of all the votes attached to the voting shares of the Offeror. The Shares owned by the Offeror are held in the name of its nominee, United Overseas Bank Nominee (Private) Limited.
