The change in interest arose pursuant to the completion of the sales and purchase agreements for the disposal of Dato' Azlan's entire stake in Asiasons Investment Managers and Porterhouse Capital Limited ("Disposal"), who collectively hold approximately 49.3% in Asiasons Capital Limited ("ACL"). ACL has a 64.35% deemed interest in the Listed Issuer. The Disposal resulted in Dato' Azlan ceasing as the substantial shareholders of ACL and the Listed Issuer.
