Limited ("SGX-ST") Listing Manual Section B: Rules of Catalist ("Catalist Rules"), authority be and is hereby given to the Directors of the Company to allot and issue shares whether by way of rights, bonus or otherwise and make or grant offers, agreements or options (collectively, "Instruments") that might or would require shares to be issued, including but not limited to the creation and issue of (as well as adjustments to) options, warrants, debentures or other Instruments convertible into shares, from time to time and upon such terms and conditions and for such purposes and to such persons as the Directors may in their absolute discretion deem fit, and (notwithstanding the authority conferred by this Resolution may have ceased to be in force) issue shares pursuant to any Instruments made or granted by the Directors of the Company while this Resolution was in force, provided that:

## Dr Lam Lee G. will, upon re-election as a Director of the Company, remain as a Lead Independent Director, Chairman of the Nominating

Committee and a member of the Audit and Remuneration Committees. Dr Lam Lee G. is considered by the Board to be independent for the purpose of Rule 704(7) of the Catalist Rules. Resolution 3

Mr Lee Keng Mun will, upon re-election as a Director of the Company, remain as an Executive Director and Chief Operating Officer of the Company.

Resolution 4 Mr Zhang Wenqing will, upon re-election as a Director of the Company, remain as a Non-Executive Director of the Company.

Resolution 5

Ms Lum Moy Foong will, upon re-election as a Director of the Company, remain as a Non-Executive Director of the Company.

Mr Lien Kait Long will, upon re-election as a Director of the Company, remain as an Independent Director of the Company. Mr Lien Kait Long is considered by the Board to be independent for the purpose of Rule 704(7) of the Catalist Rules.

Resolution 10 The Resolution 10 if passed, will empower the Directors to issue shares and/or Instruments (as defined above) in the capital of the Company.

The aggregate number of shares to be issued pursuant to Resolution 10 (including shares to be issued in pursuance of Instruments made or granted) shall not exceed 100% of the total number of issued shares (excluding treasury shares and subsidiary holdings) in the capital of the Company with a sub-limit of 50% for shares issued other than on a pro-rata basis to shareholders (including shares to be issued in pursuance of Instruments made or granted pursuant to the said Resolution). For the purpose of determining the aggregate number of shares that may be issued, the percentage of issued share capital will be calculated based on the total number of issued shares (excluding treasury shares and subsidiary holdings) in the capital of the Company at the time of the passing of this Resolution, after adjusting for (i) new shares arising from the conversion or exercise of the Instruments; (ii) new shares arising from exercising share options or vesting of share awards outstanding or subsisting at the time of passing of this Resolution provided the share options or share awards (as the case may be) were granted in compliance with Part VIII of Chapter 8 of the Catalist Rules; and (iii) any subsequent bonus issue, consolidation or subdivision of shares. Notes:

### A member of the Company entitled to attend and vote at the AGM of the Company is entitled to appoint not more than two proxies to attend 1.

- in his stead. Where a member appoints more than one proxy, he shall specify the proportion of his shares to be represented by each proxy Pursuant to Section 181 of the Companies Act, Cap. 50 of Singapore, any member who is a Relevant Intermediary is entitled to appoint one or more proxies to attend and vote at the AGM. A Relevant intermediary is either:
- (a) a banking corporation licensed under the Banking Act (Cap. 19) or its wholly-owned subsidiary which provides nominee services and
  - holds shares in that capacity; a capital markets services licence holder which provides custodial services for securities under the Securities and Futures Act (Cap. 289) and holds shares in that capacity; or
  - the Central Provident Fund ("CPF") Board established by the Central Provident Fund Act (Cap. 36), in respect of shares purchased on behalf of CPF investors.
  - A proxy need not be a member of the Company.
- The instrument appointing a proxy must be deposited at the Office of the Share Registrar of the Company, B.A.C.S. Private Limited at 8 Robinson Road #03-00 ASO Building Singapore 048544 not less than 48 hours before the time appointed for holding of the AGM. In the case of members of the Company whose shares are entered against their names in the Depository Register, the Company may reject any instrument appointing a proxy lodged if such members are not shown to have Shares entered against their names in the Depository
