The Board of Directors (“**Board**”) of Adventus Holdings Limited (“**Company**”) wishes to announce that, pursuant to the exercise of 20,000,000 warrants (“**Warrants**”) issued under the Deed Poll dated 6 January 2012, at an exercise price of S\$0.02 each, 20,000,000 new ordinary shares in the capital of the Company (“**New Shares**”) have been allotted and issued by the Company on 3 July 2014.

The New Shares are expected to be listed and quoted on the Catalist of the Singapore Exchange Securities Trading Limited with effect from 9 a.m., 7 July 2014. The New Shares will rank *pari passu* in all respect with the existing ordinary shares of the Company in issue.

Following the allotment and issuance of the New Shares, the total number of issued and paid-up ordinary shares of the Company will increase from 1,700,054,385 to 1,720,054,385 ordinary shares.
