

Presiden Direktur Mitrabara Adiperdana Widada mengungkapkan, perseroan melalui PT Cipta Tenaga Surya tengah melakukan diskusi dengan PT Perusahaan Listrik Negara (Persero) di Kalimantan terkait dengan proposal pembangunan pembangkit listrik tenaga surya (PLTS). Dia mengungkapkan, bisnis energi terbarukan merupakan bisnis yang didukung oleh pemerintah.

"Ada dua yang sedang kami jalani, pertama, fokus menjajaki bisnis pembangkit listrik tenaga surya yang akan berkerja sama dengan Engie Prancis, lalu bisnis *energy plantation* seluas 20.000 ha di Kalimantan Utara," ungkapnya di Jakarta, Senin (21/5).

Perseroan optimistis riset pembangunan PLTS rampung pada tahun ini. Dengan demikian, pada tahun depan PLTS diproyeksikan bisa beroperasi. Dia mengungkapkan, untuk menggarap bisnis *energy plantation*, perseroan akan menggandeng Idemitsu Kosan.

Pada 2018, emiten bersandi saham MBAP ini berencana memproduksi batu bara sebanyak 3,8 juta ton per tahun. Saat ini, jumlah kapasitas yang dimiliki perseroan mencapai 5 juta ton hingga 6 juta ton per tahun. Adapun, total cadangan di Malinau mencapai 29 juta ton.

Di sisi lain, pendapatan perseroan per Maret 2018 mencapai US\$75,87 juta, naik 26,54% dari posisi US\$59,95 juta pada periode yang sama tahun sebelumnya. Laba bersih per Maret 2018 mencapai US\$22,21 juta, tumbuh 28,53% dari posisi US\$17,28 juta pada periode yang sama tahun sebelumnya.

Adapun, alokasi belanja modal pada tahun ini sebesar US\$4,82 juta, atau lebih rendah dari tahun sebelumnya se nilai US\$6 juta. Belanja modal pada tahun ini akan dilakukan untuk aktivitas perawatan dan perbaikan alat-alat kerja.

Sebagai informasi, dalam rapat umum pemegang saham tahunan perseroan membagikan dividen senilai Rp404,99 miliar. (Novita S. Simamora)

berharga negara (SBN). Pada Februari, investor asing mulai agresif menjual dengan total jual bersih mencapai Rp21,6 triliun. Pada Maret, investor asing mencoba kembali masuk, tetapi lebih terbatas yakni Rp10,57 triliun.

Sayangnya, aksi beli ini tidak berlangsung lama. Pada April, investor asing kembali menjual SBN hingga total terjual Rp13,45 triliun. Ini pertama kalinya investor asing mencatatkan *net sell* khusus pada April sejak 2010.

Padahal, pada April tahun ini lembaga pemeringkat internasional Moody's Investor Service juga sudah menaikkan peringkat surat utang Indonesia dari Baa3 menjadi Baa2. Artinya, sudah 2 dari tiga lembaga pemeringkat utama dunia memberikan peringkat layak investasi satu *notch* lebih tinggi dari level terbawah *investment grade*, yakni Fitch dan Moody's.

Sebelumnya, Japan Credit Rating Agency (JCRA) juga sudah menaikkan peringkat Indonesia dari BBB

menjadi BBB+ pada Februari 2018. Demikian juga lembaga pemeringkat lain asal Jepang, yakni Rating and Investment Information Inc (R&I) menaikkan peringkat utang luar negeri Indonesia dari BBB- menjadi BBB pada Maret 2018.

Tidak berhenti sampai April, pada Mei aksi jual investor asing bahkan lebih kencang. Hingga Jumat (18/5) pekan lalu, nilai jual bersih sepanjang Mei sudah mencapai Rp18,13 triliun. Dengan demikian, sepanjang tahun berjalan 2018 atau *year-to-date* (ytd) investor asing telah tercatat *net sell* Rp8,94 triliun.

Ahmad Mikail, ekonom Samuel Sekuritas Indonesia, mengatakan bahwa kondisi defisit neraca perdagangan yang terjadi pada 3 bulan awal tahun ini menyebabkan rupiah menjadi lemah.

ASII Masih Prospektif?

Muncernya pengusa-an pasar otomotif PT Astra International Tbk. menguatkan keyakinan sejumlah analis untuk merekomendasikan beli saham emiten bersandi ASII tersebut.

Pada perdagangan kemarin, saham ASII bergerak stagnan dengan ditutup pada level yang sama dengan hari sebelumnya, yakni 6.525. Sepanjang tahun berjalan, saham ASII turun 21,38%.

Adapun, pangsa pasar ASII per April 2018 sebesar 48,9%, naik dibandingkan dengan pangsa pasar per Maret 2018 yang sebesar 48,6%. Sementara itu, pangsa pasar ASII per Februari tercatat 47,9%.

Analisis Kresna Sekuritas Franky Rivan menyatakan bahwa naiknya pangsa pasar ASII seiring dengan menurunnya daya tarik mobil rakitan Mitsubishi Motors Indonesia, yakni Xpander.

Pada April lalu, perbedaan penjualan antara Xpander dengan Avanza, produk andalan Toyota Astra Motor hanya 180 unit. Avanza terjual sebanyak 6.917 unit dan Xpander sebanyak 7.097 unit.

"Perlu dicatat bahwa pada Maret angkanya jauh lebih tinggi, yakni 396 unit di mana

Xpander 7.493 unit dan Avanza 7.097 unit," kata dia melalui riset yang dikutip, Senin (21/5).

Adapun, di pasar roda dua, *market* ASII seolah tak tergo-yahkan, yakni dengan pengusa-an pasar sebesar 75% per April 2018. Angka itu naik dibandingkan dengan pencapaian hingga Maret 2018 yang hanya sebesar 73,4%. "Secara keseluruhan kami mempertahankan rekomendasi beli dengan target harga sebesar Rp9.100," ujarnya.

Rekomendasi serupa juga disampaikan oleh analis Pamin Sekuritas Timotheos Prasetya. Dia merekomendasikan beli saham ASII dengan target harga Rp8.700 per saham.

Menurutnya, *market share* ASII di sektor otomotif roda empat akan mengalami tekanan pada kuartal II/2018. Namun, secara volume akan tumbuh seiring dengan adanya Lebaran.

"Oleh karena itu, kami meng-upgrade rekomendasi menjadi beli untuk ASII, dengan target harga Rp8.700," kata dia.

Pada kuartal I/2018, ASII mencatatkan pendapatan senilai Rp55,8 triliun, naik 14,5% secara *year-on-year* (oy). Adapun, profit dari operasional mencapai Rp7,5 triliun, naik 8,2% secara oy. (Tegar Arief)

Syrian army moves into Yarmuk after IS evacuations end


vacations of Islamic State fighters from their final hold in Syria's capital ended Monday, bringing President Bashar al-Assad closer to a major victory in the seven-year war. Through a blend of military pressure and negotiated withdrawals, Assad has flushed rebels out of territory around Damascus in recent months, leaving a pocket of IS fighters in the city's south. His troops and al-Alestinian militiamen have been since April 19 to recapture areas covering the Palestinian camp of Yarmuk and the adjacent areas of Qadam, Tadamun and al-Aswad. A ceasefire on the weekend ushered in a brief wave of evacuations that wrapped up around midday on Monday, according to the Syrian Observatory for Human Rights.

The evacuations are over, and buses took 1,600 people including IS fighters and their relatives out of southern Damascus on Sunday and Monday," said Observatory head Rami Abdel Rahman. He said Syrian troops then seized IS-held parts of Yarmuk during operations.

Abdel Rahman said IS sleeper cells may remain in Yarmuk, however, and further military operations could lie ahead before the area is declared secure.

Under the deal, the first busloads of IS fighters and civilians left southern Damascus early Sunday morning and a second batch followed the following night. The bus-based monitor said they headed toward Syria's badiyah, a stretch of desert in the country's center and east where IS still holds some territory.

Since Yarmuk and adjacent areas are under its control, Syria's government will have fully secured Damascus and its outskirts, any military threat for the time since 2012. The regime

has not confirmed any deal with IS, but in a first official comment on evacuations, a military source said on Monday that a brief ceasefire had allowed some civilians to be transferred out overnight.

The source told state news agency SANA that women and children were bussed out, but pledged the government would resume its operations at noon on Monday. AFP's correspondent in Damascus saw black smoke emerging from the capital's southern skyline about that time.

The latest evacuations, according to the Observatory, leave the government in control of Tadamun, Qadam and Hajar al-Aswad.

However, the secretive nature of the withdrawals meant it was not immediately clear how many IS fighters or civilians – if any – remained in Yarmuk, Observatory chief Rami Abdel Rahman said.

The evacuations had been taking place with no media present.

"The Syrian government does not admit to negotiating with IS and wants to make sure the convoy is not targeted by the coalition led by Washington," he said.

Last year, IS fighters and rela-



powerful Lebanese ally Hezbollah on the other.

The Damascus government was fiercely criticized over the agreement, which also enraged the United States-led coalition carrying out air strikes against IS in Syria since 2014.

The coalition sent airplanes to shadow last year's convoy, conducting bombing raids to block it from reaching IS-held territory.

Yarmuk was the largest Palestinian camp in Syria and was put under crippling government siege in 2012 – making it one of the longest sieges of Syria's war. Attacks by Syria's government, as well as rebel and jihadist infighting, have ravaged the district for years. The thriving 160,000-strong population has dwindled to just several hundred people.

Before launching its anti-IS push in Yarmuk, Syria's government managed to clear out other rebels from the area with military drives and evacuation deals.
