On 14 June 2021 ("Offer Announcement Date"), United Overseas Bank Limited announced, for and on behalf of Ong Sek Chong & Sons Pte Ltd (the "Offeror"), a mandatory conditional cash offer (the "Offer") would be made to acquire all of the issued and paid-up ordinary shares ("Shares") in the share capital of Lian Beng Group Ltd other than treasury Shares and those Shares already owned, controlled or agreed to be acquired by the Offeror and the relevant concert party group.

Following the Offer Announcement Date and up to 5.30 p.m. (Singapore time) on 26 July 2021 (the "Close of Offer"), the Offeror had acquired 22,056,900 Shares, representing approximately 4.41% of the total number of issued Shares; and

As at the Close of Offer, the Offeror had received valid acceptances amounting to 95,897,946 Shares, representing approximately 19.19% of the total number of issued Shares.

The percentage of issued share capital before and after the change is calculated based on the total number of voting issued shares of 499,689,200 (excluding 30,070,800 treasury shares).
