Mr. Don Koh was called in to attend an interview with the Corrupt Practices Investigation Bureau on 14 March 2018 in connection with the Group's investigations of certain suspected allegations in Alton International Resources Pte Ltd and PT Alton International Resources. Mr. Don Koh has been on bail in relation to an alleged offence under Section 6(b) of the Prevention of Corruption Act (Chapter 241). Mr. Derek Loh was a director of Flextech Holdings Ltd (now known as Dragon Group International Limited ("**DGIL**"), when DGIL and its Board of Directors (including Mr. Derek Loh) were called up for questioning by Commercial Affairs Department ("**CAD**") due to a technical non-compliance involving no dishonesty or fraud on the part of the Board. No charges were proceeded with and the Board members received a warning from CAD in relation to the aforementioned incident. Mr. Derek Loh resigned from the DGIL Board about 7 years ago. Please refer to the related announcement released to SGX-ST on 1 November 2018.

Save for the above, there are no other changes to the disclosures of the Retiring Directors of the Company when they were first appointed to the Board of the Company.
