1. MLHS Holdings Pte Ltd ("MLHS") is the immediate and ultimate holding company of Aspial Corporation Limited ("ACL"), and holds more than 50% of the issued shares in ACL. Accordingly, MLHS is deemed to have an interest in any shares in Aspial Lifestyle Limited (the "Shares") held by ACL.

2. Koh Lee Hwee holds more than 20% of the issued shares in MLHS. Accordingly, Koh Lee Hwee is deemed to have an interest in any Shares held by ACL and MLHS.

3. Further, pursuant to the Securities and Futures Act 2001 of Singapore, Koh Lee Hwee is deemed to have an interest in any Aspial Lifestyle Shares held by his spouse.

4. Accordingly, immediately the allotment of 61,709,489 new Shares on 12 June 2026 pursuant to the Preferential Offering (the "Preferential Offering Allotment"), Koh Lee Hwee has:

(i) a direct interest in 29,388,888 Shares, representing approximately 1.43% of the total number of Shares in issue (excluding 5,020,522 treasury shares); and

(ii) a deemed interest in: (a) 1,354,260,342 Shares in which ACL has an interest, representing approximately 65.67% of the total number of Shares in issue (excluding 5,020,522 treasury shares); and (b) 7,606,870 Shares in which Koh Lee Hwee's spouse has an interest, representing approximately 0.37% of the total number of Shares in issue (excluding 5,020,522 treasury shares).
