Atria smashes it out of the park

Latest release at Queensland's Hamilton Reach now 90% sold, with \$81m in sales

Brisbane – 15 January 2015 – Time is fast running out for buyers searching for exclusive, riverfront living less than six kilometres from Brisbane's CBD.

Frasers Property Australia's luxury \$93 million dollar project Atria, located at Hamilton Reach, Queensland has recorded more than \$81 million in sales and is now 90 per cent sold.

Atria South apartments and terrace homes sold out quickly while Atria North has limited opportunities remaining with savvy buyers recognising the exceptional value.

Cameron Leggatt, General Manager Residential Queensland, Frasers Property Australia said significant interest was coming from owner-occupiers attracted to the riverside location and community offering at Hamilton Reach.

"Atria offers unmatched value in the prestigious Northshore area with each apartment and terrace home offering more space, more inclusions and more opportunity," Mr Leggatt said.

"We've worked with award-winning Brisbane architects Arkhefield to capture the relaxed but refined Queensland lifestyle, providing calm subtropical spaces filtering natural lights and gentle breezes throughout the entire collection.

"Hamilton Reach is the only location on Brisbane's northside offering buyers well-priced, luxury homes as part of a thriving, exclusive community which we believe buyers appreciate and aspire to be part of."

The Hamilton Reach master-planned community has completed 5 stages since launch in 2011. Due for completion in 2020, the development is expected to provide over 700 properties.

Incorporated into the 2.5 hectare community is the Northshore Riverside Park, with access to green parklands, walking paths, Lookout Park on the river's edge, public BBQ facilities and green play areas.

Residents enjoy 530 metres of river frontage and enviable views of the Royal Queensland Golf Club, as well as a 25 metre swimming pool and fully equipped gym.

Hamilton Reach is within the Northshore Hamilton Urban Development area, one of Australia's largest waterfront urban renewal projects. To date, Hamilton Reach has achieved \$220 million in sales.
