## IMPERIUM CROWN LIMITED SIGNS AGREEMENT WITH BEERFEST ASIA PTE LTD TO HOLD "BEERFEST SHANDONG" AT WONDER STONE PARK

- Marks the 1<sup>st</sup> Beerfest Asia edition in the PRC
- Imperium Crown granted the usage of the trademark "Beerfest Asia" in Shandong Province

Singapore, 13 June 2018 – Imperium Crown Limited (the "Company") is pleased to announce that it has been granted the usage of the trade mark "Beerfest Asia" (the "Mark") in Shandong Province, the PRC for an initial term of 1 year by Sphere Exhibits Pte Ltd, a subsidiary of Singapore Press Holdings Limited ("SPH"). The term may be renewed on the same terms for another year, subject to the consent of the trademark owners.

The Company intends to hold the Shandong Province edition of the Mark at the Wonder Stone Park from 1 to 7 October 2018 (the "Event"). Entitled "Beerfest Shandong", the Event will be organised based on the technical rider, concept and programme plan provided by by Beerfest Asia and UnUsUaL Productions Pte Ltd ("UnUsUaL Productions"), a subsidiary of UnUsUaL Limited. The granting of the Mark is not expected to have any material effect on the consolidated net tangible assets and earnings per share of the Company and the Group for the current financial year ending 30 June 2018.

Commenting on the signing of the agreement, Mr Sun Bowen, the Group's Executive Director remarked:

"This is the first time that Beerfest Asia will be held in the PRC and we are delighted that it will be held at our Wonder Stone Park. Together with our working partners, we are confident that Beerfest Shandong will be a success and provide a wonderful platform for both domestic and international visitors to get to know more about our Wonder Stone Park. The Event is also highly scalable and together with Beerfest Asia and UnUsUaL Productions, future Beerfest editions in other cities are possible as well."
