1. The board of directors (the “**Board**”) of Annica Holdings Limited (the “**Company**”) refers to:
 - i. the Company’s Circular dated 11 December 2015 (the “**Circular**”) in relation to: (a) the issuance of up to S\$60,000,000 redeemable convertible bonds to Premier Equity Fund Sub Fund F (the “**Subscriber**”) and the allotment and issuance of up to 24,000,000,000 conversion shares pursuant to the conversion of the RCBs; (b) possible transfer of controlling interest; and (c) the allotment and issuance of up to 400,000,000 consideration shares (the “**Consideration Shares**”); and
 - ii. the Company’s announcement dated 25 November 2015 (the “**Previous Announcement**”) on the receipt of the listing and quotation notice from the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) for the listing and quotation of the Consideration Shares on the Catalist board of the SGX-ST (“**Catalist**”).

Unless otherwise defined, all capitalised terms herein shall bear the same meaning ascribed to them in the Circular and Previous Announcement.

2. The Board wishes to announce that in accordance with the terms and subject to the conditions of the Subscription Agreement, the Company has:
 - i. issued the fifth and sixth sub-tranche of the Tranche 1 RCBs, with an aggregate principal amount of S\$1,000,000, to the Subscriber on 5 January 2016 (the “**050116 Tranche 1 RCBs**”); and
 - ii. allotted and issued 88,235,294 Consideration Shares at the issue price of S\$0.0017 per Consideration Share to the Subscriber on 5 January 2016.
3. The Company will make announcement on the utilisation of the proceeds from the issuance of the 050116 Tranche 1 RCBs as and when they are materially disbursed.
4. The Consideration Shares are issued free from all claims, charges, liens and other encumbrances whatsoever and shall rank pari passu in all respects with and carry all rights similar to existing shares of the Company.
5. Following the allotment and issuance of the Consideration Shares, the number of issued and paid-up ordinary shares of the Company has increased from 1,488,749,912 to 1,576,985,206.
6. The Consideration Shares are expected to be listed and quoted for trading on the Catalist on or about 7 January 2016.
