ThaiBev holds a 100% direct interest in International Beverage Holdings Limited ("IBHL"). IBHL holds a 100% direct interest in InterBev Investment Limited ("IBIL"), which holds more than 20% of the shareholdings of Frasers Property Limited ("FPL"). FPL holds a 100% direct interest in each of Frasers Logistics & Commercial Asset Management Pte. Ltd. ("FLCAM") and Frasers Property Industrial Trust Holdings Pte. Ltd. ("FPITH"). FLCAM and FPITH directly hold an aggregate of 791,185,614 units in FLCT ("Units"). Accordingly, each of ThaiBev, IBHL, IBIL and FPL is deemed to have an interest in the aggregate of 791,185,614 Units collectively held by FLCAM and FPITH, by virtue of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

MM Group Limited ("MM Group") owns a 100% direct interest in each of Maxtop Management Corp. ("Maxtop"), Golden Capital (Singapore) Limited ("Golden Capital") and RM. Prior to 8 December 2021, each of Maxtop, Golden Capital and RM had a direct interest of 17.23%, 0.06% and 3.32% in the shareholdings of ThaiBev, respectively. Accordingly, each of MM Group, Maxtop, Golden Capital and RM was deemed to be interested in the aggregate of 791,185,614 Units, by virtue of Section 4 of the SFA.

On 8 December 2021, RM disposed all of its 833,335,000 shares in ThaiBev to Golden Capital, and Golden Capital also acquired 620,415,000 ThaiBev shares from Maxtop. Following this, Golden Capital has an aggregate interest of 1,470,000,000 ThaiBev shares (5.85%), Maxtop has an aggregate interest of 3,706,627,762 ThaiBev shares (14.76%) and RM ceased to hold any interest in ThaiBev shares. Accordingly, RM also ceased to hold any interest in Units.
