CLAS is a stapled group comprising CapitaLand Ascott Real Estate Investment Trust ("CapitaLand Ascott REIT") and CapitaLand Ascott Business Trust ("CapitaLand Ascott BT"). Each stapled security of CLAS ("Stapled Security") comprises one unit in CapitaLand Ascott REIT and one unit in CapitaLand Ascott BT. The manager of CapitaLand Ascott REIT is CLASML and the trustee-manager of CapitaLand Ascott BT is CapitaLand Ascott Business Trust Management Pte. Ltd. ("CLASBTMPL").

On 7 August 2025, SCPL has purchased a total of 5,364,200 stapled securities in CLAS at an issue price of S\$0.8686 per Stapled Security from CLASML and CLASBTMPL, both are related corporations of SCPL. In connection with the purchase, each of CLASML and CLASBTMPL has directed that such stapled securities that

it is entitled to receive as payment of management fees, be issued directly to SCPL.

In relation to item 9 of Transaction A, the percentage of total number of ordinary voting stapled securities in CLAS held "immediately before the transaction" is calculated based on 3,819,578,764 stapled securities as at 19 May 2025 (being the last change in the total number of stapled securities in CLAS), and the percentage of total number of ordinary voting stapled securities held "immediately after the transaction" is calculated based on 3,824,942,964 stapled securities as at 7 August 2025.

The percentages are rounded down to the nearest 0.01%.
