This form is for a Director/Chief Executive Officer ("CEO") to give notice of his interests in the securities of the Listed Issuer under section 133, 137N or 137Y of the Securities and Futures Act (Cap. 289) (the "SFA"). Please note that the requirement to disclose interests in participatory interests applies **only** to a director and where the Listed Issuer is a Singapore-incorporated company.
3. This electronic Form 1 and a separate Form C, containing the particulars and contact details of the Director/CEO, must be completed by the Director/CEO or a person duly authorised by him to do so. The person so authorised should maintain records of information furnished to him by the Director/CEO.
4. This form and Form C, are to be completed electronically and sent to the Listed Issuer via an electronic medium such as an e-mail attachment. The Listed Issuer will attach both forms to the prescribed SGXNet announcement template for dissemination as required under section 137G(1), 137R(1) or 137ZC(1) of the SFA, as the case may be. While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

A single form may be used by a Director/CEO for more than one transaction resulting in notifiable obligations which occur within the same notifiable period (i.e. within two business days of/of becoming aware of, the earliest transaction). There must be no netting-off of two or more notifiable transactions even if they occur within the same day.

With respect to Table 1, Kong Wan Sing's deemed interest in the ordinary shares of JustCo arises from his deemed interest in the shares of JustCo held by his wife, Liu Lu, and Sing Long Investments Pte Ltd ("SL").

Liu Lu has a direct interest in 2,612,140 ordinary shares of JustCo (the "LL Shares"). For the purposes of Section 133(4) of the SFA, Kong Wan Sing is deemed to have an interest in all the LL Shares.

SL holds 87,052,490 ordinary shares of JustCo (the "SL Shares"). Kong Wan Sing holds 42.79% of the shares of SL. Accordingly, for the purposes of Section 4 of the SFA, Kong Wan Sing is deemed to have an interest in all the SL Shares.

With respect to Table 3, Kong Wan Sing has a direct interest in 11,485,582 options under the Pre-IPO ESOP, exercisable into 11,485,582 ordinary shares of JustCo.

For the purposes of Section 133(4) of the SFA, Kong Wan Sing is deemed to have an interest in the options exercisable into ordinary shares of JustCo in which his spouse, Liu Lu, has an interest. Liu Lu has a deemed interest in 4,785,659 options, exercisable into 4,785,659 ordinary shares of the JustCo.
