

## SIA Engineering Company Sells 9% Shareholding in Safran Electronics Asia to Sagem

**SINGAPORE, 6 August 2015** - Mainboard-listed **SIA Engineering Company Limited** (SIAEC) wishes to announce that it has today sold 794,118 shares (Sale Shares) in Safran Electronics Asia Pte Ltd (SEA or the Joint Venture) to its joint venture partner, **Sagem Défense Sécurité** (Sagem) (part of the Safran Group). The Sale Shares constitute 9% of the share capital of SEA.

The shares in SEA were previously held by SIAEC and Sagem in the proportion of 49% and 51% respectively. Following completion of the sale, SIAEC and Sagem now hold 40% and 60% of the shares in SEA respectively.

Sagem purchased the Sale Shares as SEA is strategic to Sagem's aftermarket services in the region. With its increased shareholding, Sagem will bring more high technology repair capabilities into the Joint Venture to sustain its future growth.

The US\$3.56M cash consideration for the Sale Shares was based on the value of SEA's business using the Discounted Cash Flow method as documented in a valuation report dated 10 October 2014 by an independent party appointed by SEA.

Based on SEA's audited financial statements for the financial year ended 31 December 2014, the net tangible asset value of the Sale Shares is US\$2.00M.

The above transaction is not expected to have a material effect on the net tangible assets or earnings per share of the SIAEC Group for FY2015/16. None of the Directors of SIAEC has any interest, direct or indirect, in the above transaction.
