On 7 September 2018, PrimePartners Corporate Finance Pte. Ltd. announced, for and on behalf of Mountbatten Resources Pte. Ltd. (the "Offeror"), an exit offer (the "Exit Offer") for all of the issued and ordinary shares ("Shares") in the capital of LTC Corporation Limited other than those already owned, controlled or agreed to be acquired by the Offeror, its related corporations or their respective nominees.

The Offer was declared unconditional in all respects on 11 December 2018 (the "Exit Offer Unconditional Date"), and the settlement of consideration for the Shares tendered in acceptance of the Exit Offer on or before the Exit Offer Unconditional Date was made on 19 December 2018 (the "Settlement").

Prior to the Exit Offer Unconditional Date, Mountbatten Enterprises Pte. Ltd. ("ME") had a direct interest in 138,366,568 Shares, which it tendered in acceptance of the Exit Offer before the Exit Offer Unconditional Date.

As part of the Settlement, the consideration payable to ME for its Shares tendered in acceptance of the Exit Offer was applied to subscribe for shares in the Offeror, which resulted in ME becoming the holding company of the Offeror.

Following the Settlement, as at 5.00 p.m. on 19 December 2018, the Offeror had a direct interest in 139,460,040 Shares and a deemed interest in 763,199 Shares that have not been settled (collectively, the "LTC Shares"). As the holding company of the Offeror, ME has a deemed interest in the LTC Shares in which the Offeror has an interest.
