## APPLICATION FOR STRIKING OFF OF A DORMANT SUBSIDIARY

The board of directors (the "Board" or "Directors") of Resources Global Development Limited (the "Company", together with its subsidiaries, the "Group") wishes to announce that the Company had, on 5 May 2022, submitted an application to the Accounting and Corporate Regulatory Authority ("ACRA") to strike off a dormant subsidiary, RG Nutrients Pte. Ltd. ("RGN"), from the Register of Companies pursuant to Section 344A of the Companies Act 1967 ("Strike-Off").

RGN, incorporated in Singapore on 22 June 2020, is a dormant company which is 60% owned by the Company. The remaining equity interests of RGN is 25% owned by Mr Francis Lee<sup>1</sup> and 15% owned by Ms Ma Thandar Yin<sup>2</sup>.

RGN was incorporated for the purpose of supplying fertilizer products mainly targeting customers based in Myanmar and Cambodia, but remained dormant since its incorporation due to the ongoing COVID-19 pandemic and the recent political event in Myanmar. The striking off of RGN is not expected to have any significant effect on the net tangible assets or earnings per share of the Group for the financial year ending 31 December 2022.

Save as disclosed above, none of the Directors or any of the substantial shareholders of the Company or their respective associates have any interest, directly or indirectly (other than through their respective shareholdings (if any) in the Company), in the Strike-Off.
