Thai Beverage Public Company Limited ("THBEV" and its shares, "THBEV Shares") holds a 100% direct interest in International Beverage Holdings Limited, which in turns holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL has a direct interest of 28.41% in the shares of the Company.

Siriwana Co., Ltd. ("Siriwana") holds a direct interest in 11,368,060,000 THBEV Shares representing approximately 45.26% in THBEV Shares. Siriwana is therefore deemed to be interested in all the shares in the Company in which IBIL has an interest.

Charoen Sirivadhanabhakdi and his spouse Khunying Wanna Sirivadhanabhakdi jointly hold a direct interest of 51% in the shares of Siriwana. The remaining 49% in the shares of Siriwana is held directly by Shiny Treasure Holdings Limited ("Shiny Treasure"), which is in turn wholly-owned by Charoen Sirivadhanabhakdi and Khunying Wanna Sirivadhanabhakdi.

On 13 December 2021, pursuant to an internal restructuring, Siriwanan Co., Ltd ("Siriwanan"), which is wholly-owned by Siriwana, entered into a conditional sale and purchase agreement ("SPA") with Golden Capital (Singapore) Limited ("Golden Capital") to acquire from Golden Capital (the "Transaction") its entire stake of 1,470,000,000 THBEV Shares representing a direct interest of approximately 5.85% in the issued share capital of THBEV (the "Sale Shares"). Completion of the Transaction has not taken place and is subject to the satisfaction of certain conditions as specified under the SPA. Siriwanan therefore has a deemed interest in the Sale Shares. Following the completion of the Transaction, Siriwana will hold directly and indirectly more than 50% interest in THBEV.

Following the entry into the SPA, Shiny Treasure is deemed to be interested in all the THBEV Shares in which Siriwana has an interest, and in all the shares in the Company in which IBIL has an interest.
