Koh Wee Meng ("KWM") is the sole shareholder of the Offeror, and is deemed interested in the Fragrance Shares held by the Offeror, pursuant to Section 4 of the Securities and Futures Act (Chapter 289 of Singapore).

KWM tendered his 5,015,500,000 Fragrance Shares in acceptance of the Offer.
