Post internal corporate reorganisation, the Units held directly by AIHPL is 41,490,190. AIHPL has a direct 100% interest in AIMS Fund Management (Cayman) Limited ("AFMCL") and is therefore also deemed to have an interest in the Units held by AFMCL and the Units AFMCL has an interest in.

As a result, AFH has increased its total interest from 7.43% to 14.32%.
