The Board of Directors (the "Board") of NutryFarm International Limited (the "Company", and together with its subsidiaries, the "Group") wishes to announce the change of the Company's financial year end from 31 March to 30 September. Following the above change, the current financial year of the Company will end on 30 September 2020 ("FY2020"), and the next set of audited financial statements for the financial period ending 30 September 2020 will cover a period of 18 months from 1 April 2019 to 30 September 2020.

Due to the business disruptions in the People's Republic of China ("PRC") in connection with the COVID-19 outbreak and the necessity to take into account the health and safety of the staff of the Company, the Company had not been able to conduct any audit fieldwork and anticipates that it will not be able to complete the audit work in time for the former financial year end on 31 March 2020. Having considered the uncertainties in the COVID-19 recovery progress and the resumption of normal business activity in the PRC, the Board takes the view that it is in best interest of the Company to change the financial year end to 30 September to facilitate the audit work being carried out and completed by the stipulated timeframe.

In accordance with Rule 705 of the Listing Manual of the Singapore Exchange Securities Trading Limited ("SGX-ST"), the Company will be releasing announcements of its financial results as set out below:
