- **Successfully secured SAC accreditation for GHG validation and verification (ISO 14064-1, Scopes 1–3)**
- **Strengthens position as regional accredited VVB with recognition under MLAs with Asia Pacific Accreditation Cooperation and International Accreditation Forum, and DSM accreditation**

Singapore, 4 June 2025 – LMS Compliance Ltd. (“**LMS Compliance**” or the “**Company**”, and together with its subsidiaries, the “**Group**”) is pleased to announce the receipt of key industry accreditation from the Singapore Accreditation Council (“**SAC**”). The accreditation will strategically position the Group to capitalise on emerging opportunities within the evolving sustainability landscape, including increasingly stringent environmental regulations as well as the growing market demand for independent carbon emissions verification and comprehensive environmental, social and governance (“**ESG**”) reporting services.

1. Strategic Milestone: SAC Accreditation

LMS Compliance, through its wholly-owned subsidiary SG CO2 Pte. Ltd. (“**SGCO2**”), has been accredited as a Validation and Verification Body (“**VVB**”) by the SAC based on the ISO 14064-1 standard. This accreditation authorises SGCO2 to independently verify Scope 1, Scope 2 and Scope 3 greenhouse gas (“**GHG**”) emissions, positioning SGCO2 as one of only six organisations in Singapore to attain this accreditation.

The accreditation spans 12 of 13 scopes, excluding only Carbon Capture and Storage (CCS), and affirms the Group’s technical competence and impartiality in delivering ESG assurance services.

SAC is a signatory to multilateral recognition arrangements (“**MLAs**”) under both the Asia Pacific Accreditation Cooperation (“**APAC**”) and the International Accreditation Forum (“**IAF**”).

Accordingly, verification statements issued by SGCO2 are internationally recognised, thereby adding significant value for clients of LMS Compliance with cross-border operations and regulatory reporting requirements.

2. **Accreditations Boost Regional Capabilities**

The Group has secured the VVB accreditation from the SAC, in addition to its existing VVB accreditation by the Department of Standards Malaysia (“**DSM**”), the national accreditation body of Malaysia. With both recognitions in place, LMS Compliance is now recognised as a regionally accredited VVB across two key Southeast Asian markets, thereby strengthening its ability to support the GHG assurance needs of its clients in both countries.

This milestone reinforces LMS Compliance’s ambition to lead in ESG assurance across the region, aligning with international standards such as ISO 14064-1 Greenhouse Gases, ISO/IEC 17029 Conformity Assessment, and enhancing its global credibility through MLAs under APAC and IAF.
