ACCIDENT AT CHANGI EAST WORKSITE

The board of directors (the “**Board**”) of the Company, together with its subsidiaries (the “**Group**”), would like to inform all stakeholders of an incident where a tipper truck (the “**Tipper Truck**”) hit and ran over a site supervisor, an Indian national (“**the Incident**”). The Incident took place at a stockpile area in the Proposed Development of Changi East to Effect 3 Runway Operations at Singapore Changi Airport- Package 1 (the “**Project**”).

The Project is located at the site of a 70:30 Joint Venture between Samsung C&T Corporation, and the Company’s wholly-owned subsidiary, Koh Brothers Building & Civil Engineering Contractor (Pte.) Ltd. (the “**Joint Venture**”) (“**KBCE**”).

The Tipper Truck belongs to Lam Hwa Engineering & Trading Pte Ltd (“**Lam Hwa**”) who was engaged by SNK Engineering & Trading Pte Ltd (“**SNK**”). SNK is a subcontractor engaged by the Joint Venture for the final grading works in the Project.

The site supervisor was employed by KBCE. KBCE was engaged for a separate subcontract for works to be carried out within the Project site.

Investigations are currently being carried out by the Ministry of Manpower and the Police on the cause of the incident which resulted in the death of the site supervisor. The Police have arrested the driver of the Tipper Truck in connection with the case, and the driver has since been released on bail. In the meantime, all operations involving tipper trucks and works at the stockpile area have been suspended.

The Board wishes to express the Company’s heartfelt sympathies to the family of the site supervisor. The Group will provide the necessary assistance to the family of the site supervisor.

At the same time, the Company will co-operate with the authorities in their investigations and will make further announcements should there be any material developments in this matter.
