The change in Mr Yuen Kuan Moon ("Mr Yuen")'s deemed interest is a consequence of the vesting of the performance shares granted to him in 2021, 2022 and 2023 (see details in paragraphs 2, 3 and 4 below). The deemed interest of 5,102,976 shares immediately after the transaction referred to in Table 1 comprises: (i) 6,360 ordinary shares held by Ms Tan Chay Ngee, spouse of Mr Yuen; and
 - (ii) an aggregate of up to 5,096,616 ordinary shares in Singapore Telecommunications Limited ("Singtel") awarded to Mr Yuen in 2021, 2022 and 2023 (see paragraphs 2, 3 and 4 below) pursuant to the Singtel Performance Share Plan 2012 ("PSP 2012"), subject to certain performance conditions being met and other terms and conditions. Depending on the extent of the satisfaction of the relevant performance criteria, up to an aggregate of 7,190,857 shares may be released pursuant to the conditional awards granted.
 - 2. Performance shares granted to Mr Yuen in 2021:
 - (i) In respect of the 170,659 shares comprised in the Restricted Share Award ("RSA") granted to Mr Yuen in 2021 under the PSP 2012, 100% or 170,659 of such shares have vested in accordance with the Rules of the PSP 2012. One-third or 56,887 of such shares were released to Mr Yuen on 1 June 2022, one-third or 56,886 of such shares were released to Mr Yuen on 1 June 2023 and one third or 56,886 of such shares were released to Mr Yuen on 3 June 2024.
 - (ii) In respect of the One-off Long-Term Incentive Award granted to Mr Yuen in 2021, depending on the extent of satisfaction of the relevant performance criteria, up to an aggregate of 6,282,723 shares may be released.
 - 3. Performance shares granted to Mr Yuen in 2022:
 - (i) In respect of the 908,698 shares comprised in the RSA granted to Mr Yuen in 2022 under the PSP 2012, two-thirds or 605,799 of such shares have vested in accordance with the Rules of the PSP 2012. One-third or 302,900 of such shares were released to Mr Yuen on 1 June 2023, and one-third or 302,899 of such shares were released to Mr Yuen on 3 June 2024. The balance one-third or 302,899 of such shares will vest to Mr Yuen, in accordance with the Rules of the PSP 2012, on or after 1 June 2025.
 - 4. Performance shares granted to Mr Yuen in 2023:
 - (i) In respect of the 907,853 shares comprised in the RSA granted to Mr Yuen in 2023 under the PSP 2012, one-third or 302,618 of such shares have vested and released to Mr Yuen in accordance with the Rules of the PSP 2012 on 3 June 2024. The balance two-thirds or 605,235 of such shares will vest to Mr Yuen in two equal tranches, in
