APPROVAL FOR EXTENSION OF TIME TO ANNOUNCE THE COMPANY'S UNAUDITED FINANCIAL STATEMENTS FOR THE FIRST QUARTER PERIOD ENDED 31 MARCH 2021 ("Q1 2021") ("Q1 FS")

The Board of Directors ("**Board**") of Asiatravel.com Holdings Ltd ("**Company**"), together with its subsidiaries, ("**Group**") refers to the Company's announcement dated 14 May 2021 ("**Previous Announcement**") in relation to its application and reasons for seeking a further time extension until 31 July 2021 to announce its Q1 FS. Unless otherwise defined herein or the context otherwise requires, all capitalized terms shall have the same meanings as defined in the foregoing announcements.

The Company wishes to announce that on 15 June 2021, the Company received a letter from SGX setting out that based on the information provided to the SGX, the SGX had no objection to the Company's application for 2.5-month extension of time till 31 July 2021 to announce its Q1 FS ("**Waiver**"), subject to the fulfillment of the following conditions:

- a) the Company announcing the Waiver granted, the reasons for seeking the Waiver, the conditions as required under Catalist Listing Rule 106 and if the Waiver conditions have been satisfied. If the Waiver conditions have not been met on the date of the announcement, the Company must make an update announcement when the conditions have all been met; and
- b) submission of a written confirmation from the Company that it is not aware of any information that will have a material bearing on investors' decision which has yet to be announced by the Company ("**Written Confirmation**").

The Company had announced its reasons for seeking the Waiver in the Previous Announcement and had submitted the Written Confirmation.

The Company will update Shareholders as and when there are material developments relating to any of the abovementioned matters.

Shareholders and potential investors of the Company are advised to read this announcement and any further announcements by the Company carefully. Shareholders are advised to refrain from taking any action in respect of their securities in the Company, which may be prejudicial to their interests, and to exercise caution when dealing in the securities of the Company. In the event of any doubt, Shareholders and potential investors of the Company should consult their stockbrokers, bank managers, solicitors, accountants or other professional advisers.
