The change in interests took place as a result of a voluntary conditional general offer ("Offer") made by Oversea-Chinese Banking Corporation Limited, for and on behalf of TKL & Family Pte. Ltd. ("Offeror") on 15 December 2021 to acquire all the issued and paid-up ordinary shares ("Shares") in the capital of Roxy-Pacific Holdings Limited ("Company") at the Offer price of S\$0.485 in cash for each Share ("Offer Price"), other than those already owned, controlled or agreed to be acquired by the Offeror in accordance with Section 139 of the Securities and Futures Act 2001 and the Singapore Code on Take-overs and mergers. On 28 January 2022, Oversea-Chinese Banking Corporation Limited, for and on behalf of the Offeror, announced that the Offer had turned unconditional in all respects.

Before the completion of the Offer, Mr. Teo Hong Yeow is deemed interested in 20,625 shares held by his spouse.

An aggregate of Shares comprising 31,627,062 Shares held by Mr. Teo Hong Yeow were validly tendered in acceptance of the Offer and in accordance with his respective undertakings as disclosed in the offer document dated 5 January 2022. Mr. Teo Hong Yeow's spouse also tendered the 20,625 shares in acceptance of the Offer.

Mr Teo Hong Yeow have agreed to be allotted and issued new ordinary shares in the capital of the Offeror for an aggregate subscription price that will be set-off in full against the consideration that would otherwise be payable by the Offeror to him for his Shares at the Offer Price pursuant to the acceptance of the Offer by him.

After the completion of the Offer, Mr. Teo Hong Yeow would own 13.08% of the Offeror. Accordingly, following the tender by Mr. Teo Hong Yeow of his Shares in acceptance of the Offer, pursuant to Section 4 of the Securities and Futures Act 2001 and based on the information set out in the offer document dated 5 January 2022, Mr. Teo Hong Yeow is deemed interested in the 1,175,140,802 Shares held by the Offeror arising from the acceptances for the Offer as at 28 January 2022.
