Pursuant to the Issuer's first omnibus announcement issued on 6 June 2024 (the "Omnibus Announcement 1") and the Placement Announcement issued on 6 June 2024 (the "Placement Announcement"), Wong Yew Chian Terence had a deemed interest in 999,999,999 Placement Shares and 500,000,001 Warrant Shares (as defined in the Omnibus Announcement 1) under his name and via Azure All-Star Fund Pte. Ltd. and Azure Prime Fund VCC on behalf of MG Capital (by virtue of his controlling interest in the fund manager to the aforesaid funds).

Based on the enlarged issued and paid-up share capital of the Issuer following and assuming the completion of all subscriptions and allotments, as well as the mutual agreement not to proceed with the warrants as announced in the Omnibus Announcement made by the Issuer dated 25 June 2024 (the "Omnibus Announcement 2"), as described in the Omnibus Announcement 2 (the "Enlarged Share Capital"), Wong Yew Chian Terence's total shareholding as a percentage of the Enlarged Share Capital will amount to 6.44%, through:

- (a) 533,333,333 Shares to be issued and allotted to Wong Yew Chian Terence;
- (b) 666,666,667 Shares to be issued and allotted to Azure All-Star Fund Pte. Ltd.; and
- (c) 333,333,333 Shares to be issued and allotted to Azure Prime Fund VCC on behalf of MG Capital.
