1. INTRODUCTION

Merrill Lynch (Singapore) Pte. Ltd. ("**MLS**") refers to the announcement dated 20 July 2016 ("**Joint Announcement**") made jointly by SMRT Corporation Ltd ("**Offeree**"), which is listed on the Singapore Exchange Securities Trading Limited, and Belford Investments Pte. Ltd. ("**Offeror**") relating to the proposed acquisition ("**Acquisition**") by the Offeror of all the issued and paid-up ordinary shares ("**Shares**") in the capital of the Offeree, from the shareholders of the Offeree (other than those already held by the Offeror's parent, Temasek Holdings (Private) Limited), by way of a scheme of arrangement under Section 210 of the Companies Act (Cap. 50) of Singapore, in accordance with the Singapore Code on Take-overs and Mergers ("**Code**").
