Singapore, 18 March 2015 – Hutchison Port Holdings Management Pte. Limited, the Trustee-Manager of Hutchison Port Holdings Trust (“**HPH Trust**”), would like to inform all unitholders of HPH Trust that the distribution of 22.30 Hong Kong cents per unit for the period from 1 July 2014 to 31 December 2014 will be paid on Friday, 27 March 2015.

Unitholders who have not opted to receive their distribution in Hong Kong dollars or US dollars, will receive it in Singapore dollars.
