Temasek was not aware of the change in the percentage level of its deemed interest in Shares until Fullerton Fund Management Company Ltd ("Fullerton") reported the transaction which triggered this notification to Temasek on 6 February 2024. Fullerton is an independently managed Temasek portfolio company.
