AWARD OF S\$19.24 MILLION SEWER CONTRACT

The Board of Directors (“**Directors**”) of Trittech Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that its wholly-owned subsidiary, Presscrete Engineering Pte Ltd, had on 2 December 2014, won a tender with a contract value of approximately S\$19.24 million in relation to the works for the “Proposed Sewers in Sembawang Road and Sembawang Avenue Areas” (the “**Contract**”) by the Public Utilities Board of Singapore.

The project is located in the vicinity of Sembawang Road, Sembawang Avenue, Future Sembawang Link, Jalan Legundi and Jalan Ulu Sembawang. The main scope of the Contract includes, *inter alia*, the supply, delivery to site, storage, loading and unloading, laying and installation of (i) approximately 30m of 300mm, 35m of 400mm, 120m of 450mm, 300m of 600mm internal diameter polymer concrete/vitrified clay pipes at Sembawang Road and Jalan Legundi; (ii) approximately 1800m of 1800mm, 1100m of 2100mm internal diameter HDPE-lined reinforced concrete pipes by pipe jacking method at Sembawang Road, Sembawang Avenue, Future Sembawang Link and Jalan Ulu Sembawang areas; and (iii) the construction of 26 reinforced concrete manholes including 2 vortex drops, backdrops connection and existing sewer diversion along the proposed sewer lines.

The commencement date of the Contract is 17 December 2014 and the expected completion date is 16 June 2017. The defects liability period is for 24 months from 17 June 2017 to 16 June 2019.

None of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the Contract (other than through their shareholdings in the Company).

The Contract is not expected to have any material impact on the consolidated earnings per share and/or net tangible assets per share of the Group for the current financial year ending 31 March 2015.
