PRICING OF \$\$30,000,000 2.645 PER CENT. NOTES DUE 2022 PURSUANT TO THE \$\$1,000,000,000 MULTICURRENCY MEDIUM TERM NOTE PROGRAMME UNCONDITIONALLY AND IRREVOCABLY GUARANTEED BY HSBC INSTITUTIONAL TRUST SERVICES (SINGAPORE) LIMITED (IN ITS CAPACITY AS TRUSTEE OF FRASERS CENTREPOINT TRUST)

Frasers Centrepoint Asset Management Ltd. (the "**Manager**"), as manager of Frasers Centrepoint Trust ("**FCT**"), wishes to announce that FCT MTN Pte. Ltd. (the "**Issuer**"), a wholly-owned subsidiary of HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of FCT) (the "**FCT Trustee**"), has today priced S\$30,000,000 in aggregate principal amount of 2.645 per cent. notes due 2022 comprised in Series 012 (the "**Series 012 Notes**") to be issued under its S\$1,000,000,000 Multicurrency Medium Term Note Programme. The Series 012 Notes are expected to be issued on 5 June 2017 and will be unconditionally and irrevocably guaranteed by the FCT Trustee.

CIMB Bank Berhad, Singapore Branch and DBS Bank Ltd. have been appointed as the joint lead managers and bookrunners for the Series 012 Notes. The Series 012 Notes are expected to be assigned a rating of "BBB+" by Standard & Poor's Rating Services. The Series 012 Notes will mature on 6 June 2022 and bear a fixed interest rate of 2.645 per cent. per annum payable semi-annually in arrear.

The Issuer will use the proceeds arising from the issue of the Series 012 Notes (after deducting issue expenses) to refinance existing borrowings of FCT.
