**APPLICATION FOR SIXTH EXTENSION OF TIME OF JUDICIAL MANAGEMENT ORDER**

---

The Judicial Manager (the “**JM**”) of NutryFarm International Limited (the “**Company**”) refers to the Company’s announcements dated 28 June 2022, 23 November 2022, 17 January 2023, 14 June 2023, 1 August 2023, 11 August 2023, 7 September 2023, 1 November 2023, 10 November 2023, and 4 March 2024 in relation to the order of the High Court of Singapore dated 28 June 2022 placing the Company under judicial management (the “**Judicial Management Order**”), the first extension of the Judicial Management Order until 24 June 2023, the second extension of the Judicial Management Order until 10 August 2023, the third extension of the Judicial Management Order until 10 November 2023, the fourth extension of the Judicial Management Order until 10 March 2024, the fifth extension of the Judicial Management Order until 10 September 2024.

The JM wishes to inform that the JM has, on 21 August 2024, made an application to the Court for, *inter alia*, the validity of the Judicial Management Order be further extended for a further three (3) month period, up to and including 10 December 2024 (the “**Sixth Extension Application**”).

The Court has fixed the hearing of the Sixth Extension Application for 9 September 2024 at 10:00am. The Court has also directed the following:

1. Immediate notice of the Sixth Extension Application as well as the directions below is to be given to all parties who may be affected by the orders sought in the Sixth Extension Application.
2. Any party who objects to the Sixth Extension Application is to file an affidavit by 29 August 2024, 4pm. The applicant is to file the reply affidavit, if any, by 2 September 2024, 4pm. All affidavits to be served by email followed by e-service.
3. The following are to be tendered to Court by 4 September 2024, 4pm:
  - a. Submissions and bundle of authorities which are to be exchanged, e-filed and tendered to Court. Submission of each party is limited to 35 pages.
  - b. The attendance list of parties who wish to attend, indicating whether the party attending is supporting or opposing the application.
  - c. A time bank.

Copies of the papers for the Sixth Extension Application will be made available to all parties who may be affected by the orders sought in the Sixth Extension Application upon request in writing to the JM at [projectnova.sg@mazars.com.sg](mailto:projectnova.sg@mazars.com.sg).

The JM will provide further updates via SGXNET as and when there are material developments in relation to the Judicial Management of the Company.

Trading in the Company’s securities on the SGX-ST had been voluntarily suspended by the Company since 11 April 2022.
