Further to the completion of the court-sanctioned scheme of arrangement and all-share merger of Aberdeen Asset Management PLC and Standard Life plc which became effective on 14 August 2017, the relevant substantial shareholding notifications have been made by Standard Life Aberdeen plc in respect of the aggregate interests of Standard Life Aberdeen plc and its subsidiaries, including but not limited to Aberdeen Asset Management PLC (collectively, the “SLA Group”), in BUKIT SEMBAWANG ESTATES LIMITED. In

particular, while a Form 3 was filed by Standard Life Aberdeen plc on 30 October 2017 in respect of the change of aggregate interest of the SLA Group in BUKIT SEMBAWANG ESTATES LIMITED, Aberdeen Asset Management PLC did not make a similar filing in respect of a similar change of its interest in BUKIT SEMBAWANG ESTATES LIMITED. This submission is a corrective retrospective disclosure for AAM PLC.
