AWARD OF S\$18.479 MILLION CONSULTANCY CONTRACT BY THE PUBLIC UTILITIES BOARD

The Board of Directors (“**Directors**”) of Trittech Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that a consortium between its wholly-owned subsidiary, Trittech Consultants Pte Ltd (“**Trittech Consultants**”) and Black & Veatch (Sea) Pte Ltd (the “**Black Veatch – Trittech Consultants Consortium**”), had on 07 November 2014 been awarded a S\$18.479 million contract, “Professional Engineering Services for Murnane Pipeline Project” (the “**Contract**”) by the Public Utilities Board.

Pursuant to the Contract, the Black Veatch – Trittech Consultants Consortium has been appointed as consultants for the provision of professional engineering services for a proposed 2200/1600mm diameter portable water pipeline system via the Rail Corridor from Murnane Service Reservoir to the city, and a spur 1600mm diameter portable pipeline to Fort Canning Service Reservoir. The services also include mechanical, electrical, instrumentation, control and automation works, supervisory control and data administration works at Murnane Service Reservoir, Fort Canning Service Reservoir and along the water pipeline system.

The portion of Contract allocated to Trittech Consultants is S\$8,826,000, representing 47.76% of the total Contract value.

The commencement date of the Contract is 10 November 2014, and the professional engineering services are expected to be completed within 54 months, i.e. till 09 May 2019.

None of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the Contract (other than through their shareholdings in the Company).

The Contract is not expected to have any material impact on the consolidated earnings per share and/or net tangible assets per share of the Group for the current financial year ending 31 March 2015.
