The Company had, under its CP Facility Programme, launched the third series of its commercial papers with a tenor of 3 months ("GSH_D003_3/SGD Issue") represented by digital tokens ("Tokens") on 21 November 2024. The GSH_D003_3/SGD Issue was issued at an interest rate of 4.80% per annum, and matures on a date falling on the expiry of ninety-one (91) days from the issuance of the GSH_D003_3/SGD Tokens that are issued by the Company and listed on the SDAX Platform to accredited investors and institutional investors.

Mr Goi Kok Ming (Wei Guoming) has subscribed for 75 Tokens with an aggregate principal amount of S\$750,000 under the GSH_D003_3/SGD issue.

The GSH_D003_3/SGD Issue had closed on 12 December 2024, and Mr Goi Kok Ming (Wei Guoming) was issued 75 Tokens in respect of the GSH_D003_3/SGD Issue on 12 December 2024.
