UNAUDITED KEY OPERATING FIGURES FOR DECEMBER 2023

Singapore/Hong Kong – 5 January 2024 – Yanlord Land Group Limited (Z25.SI) ("Company" and together with its subsidiaries, "Yanlord" or "Group"), a Singapore Exchange-listed real estate developer focusing on developing high-end integrated commercial and residential property projects in strategically selected high-growth cities in the People's Republic of China ("PRC") and Singapore, today announced the unaudited key operating figures of (i) the Group together with its joint ventures and associates; and (ii) other property development projects under the Group's project management business bearing the "Yanlord" brand name, for the month of December 2023 and for the full year ended 31 December 2023.

- In December 2023, the Group together with its joint ventures and associates' total contracted pre-sales from residential and commercial units, and car parks amounted to approximately RMB3.118 billion on a total contracted gross floor area ("GFA") of 94,382 square metres ("sqm"), a decrease of 49.1% and 50.7% respectively compared to the corresponding period of 2022.
- For the full year ended 31 December 2023, the Group together with its joint ventures and associates' total contracted pre-sales from residential and commercial units, and car parks was approximately RMB32.352 billion on a total contracted GFA of 1,237,468 sqm, a decrease of 52.5% and 13.7% respectively compared to the corresponding period of 2022.
- In addition, a total of approximately RMB1.997 billion of subscription sales of the Group together with its joint ventures and associates was recorded as at 31 December 2023 and is expected to be subsequently turned into property contracted pre-sales in the following months.
- In December 2023, the total contracted pre-sales of other property development projects under the Group's project management business bearing the "Yanlord" brand name was approximately RMB225 million on a total contracted GFA of 9,622 sqm.
- For the full year ended 31 December 2023, the total contracted pre-sales of other property development projects under the Group's project management business bearing the "Yanlord" brand name was approximately RMB1.584 billion on a total contracted GFA of 73,971 sqm.

Yanlord is a real estate developer focusing on developing high-end fully-fitted residential, commercial and integrated property projects in strategically selected key and high-growth cities in the PRC and Singapore. The Company has been listed on the Mainboard of the Singapore Exchange since June 2006. As at 30 June 2023, the Group's total asset was approximately RMB184.846 billion.

Since Yanlord's foray into the PRC property market in 1993, it has successfully developed a number of large-scale residential property developments with international communities of residents. Building on its established track record for developing high-end residential property developments in prime locations within affluent cities of the PRC, the "Yanlord" name has been developed into a premium brand synonymous with quality within the property development industry of the PRC. Typically, Yanlord's residential property developments are characterised by large-scale, multi-phased projects designed and built by international architects, leading designers and reputable contractors. Currently, Yanlord has an established presence in over 20 key high-growth cities within the six major economic regions of the PRC. In Singapore, Yanlord currently has three residential projects under development, namely Leedon Green, Dairy Farm Residences and Hillock Green.

Since 2003, Yanlord has been developing high-quality commercial and integrated properties for long-term investment purpose, such as shopping malls, offices, serviced apartments and hotels. Currently, Yanlord holds a portfolio of core completed investment and hotel properties, including Yanlord Landmark and Hengye International Plaza in Chengdu; Yanlord Riverside Plaza in Tianjin; Yanlord Marina Centre in Zhuhai; Crowne Plaza Sanya Haitang Bay Resort in Sanya; Yanlord Landmark in Nanjing; and Yanlord Reverie Plaza in Shenzhen, in the PRC. Through the acquisition of then another Singapore Exchange-listed company — United Engineers Limited, the Group holds a high-quality investment property portfolio and hotels in Singapore, including UE BizHub CITY (including Park Avenue Clemenceau), UE BizHub TOWER, UE BizHub WEST, Rochester Mall and Park Avenue Rochester and Park Avenue Robertson. These projects are generating a growing rental income and increase asset value of the Group.
