### **MY CO2 Wins the AMMI Sustainability Innovation Award**

The Group’s wholly-owned subsidiary, MY CO2 Sdn Bhd (“**MY CO2**”), has been recognised with the Sustainability Innovation Award at the AMMI ESG Excellence Awards 2025. MY CO2 provides testing, assessment, certification and assurance services, with expertise in supporting environmental, social and governance (“**ESG**”) compliance and reporting requirements.

The AMMI ESG Excellence Awards 2025 recognises member companies that demonstrate a measurable commitment to environmental stewardship, social responsibility and good

governance in Malaysia. This recognition reflects MY CO2's commitment to advancing sustainability standards and reinforces the Group's strategic focus on ESG-related services.

#### **Prismatic Technologies Deploys Slope Monitoring System for the Penang Government**

Prismatic Technologies Sdn Bhd (“**Prismatic**”), an associated company of the Group in which the Group holds a 30% equity interest, specialises in automated data generation solutions for sustainability reporting. Prismatic has successfully designed and manufactured the Slope Monitoring & Prediction System (“**SMPS**”), a system engineered for continuous slope monitoring. The SMPS has been deployed for the Penang State Government as a pilot project at Jalan Tun Sardon, representing one of the first real-time slope stability monitoring initiative of its kind within Penang.

The SMPS comprises three continuously operating sensor modules: (1) the Deep Soil Moisture Probe (DSMP), (2) Slope Monitoring Coupler (SMC) with inclinometer functionality, and (3) the Flood Monitoring Predictor (FMP), which functions as a compact on-site weather station. By correlating weather data with slope stability indicators, the SMPS provides early detection of instability conditions, thereby enabling authorities to take preventive action before critical situations develop.

This predictive approach transforms slope management practices from reactive responses to proactive risk mitigation, thereby enhancing public safety whilst delivering quantifiable environmental monitoring outcomes for ESG reporting purposes.

#### **MY CO2 Certification Appoints Sales Agent for its Japan Expansion**

MY CO2 Certification Sdn Bhd, which specialises in testing, certification and assurance services, has appointed Trinity Management Japan (“**Trinity**”) as its sales agent to expand its market presence in Japan.

The tenure of the agreement is three years, effective since 1 June 2025, with an option to renew for an additional three years. Pursuant to the agreement, Trinity will drive sales performance within the designated territory, develop strategic marketing plans, conduct market research and cultivate relationships with existing and prospective customers.

### **Completion of ACCLAB Malaysia Acquisition**

Anchor Technology Holdings Co Ltd, the Group's newly acquired subsidiary, completed the acquisition of ACCLAB Malaysia Sdn Bhd ("ACCLAB Malaysia") on 3 September 2025.

ACCLAB Malaysia, incorporated in February 2025, provides regulatory consulting, product development, certification support and testing services for food safety and quality. The company also offers certification services for organic and plant-based standards. Its technical capabilities include preparing documentation supporting GRAS (Generally Recognized as Safe) and NDI (New Dietary Ingredient) product registrations in the United States, amongst other regulatory requirements.

This acquisition strengthens the Group's service offerings within the food safety and regulatory compliance sector.

### **Singapore Anti-Greenwashing Rules Create Verification Services Opportunities**

Singapore has introduced anti-greenwashing regulations, primarily based on the Consumer Protection (Fair Trading) Act (CPFTA) of Singapore, which prohibits false or misleading environmental claims. In October 2025, the Competition and Consumer Commission of Singapore (CCS) issued new guidelines establishing five core principles for environmental claims: they must be true and accurate, clear and understandable, meaningful, accompanied by material information and supported by credible evidence.

The introduction of these guidelines presents opportunities for LMS Compliance's verification and assurance services. As regulatory scrutiny of environmental claims intensifies, organisations require independent verification to demonstrate compliance and substantiate their ESG disclosures. The Group's established capabilities in testing, assessment and certification position it to support clients in meeting these regulatory requirements whilst building stakeholder confidence.
