(1) Dr Shi Xu is the sole shareholder of Pearl Yard Holdings Inc. ("Pearl Yard"). Accordingly, for the purposes of Section 4 of the Securities and Futures Act 2001 of Singapore ("SFA"), Dr Shi Xu is deemed to have an interest in 253,709,960 Shares held by Pearl Yard.

(2) Dr Shi Xu holds 50% of the total issued shares in Neufont Investment Pte. Ltd. ("Neufont"). Accordingly, for the purposes of Section 4 of the SFA, Dr Shi Xu is deemed to have an interest in the 500,000 Shares held by Neufont.

(3) In addition, for the purposes of Section 133(4) of the SFA, Dr Shi Xu is deemed to have an interest in 38,882,893 Shares in which his spouse, Mdm Jin Xiao Qun, has an interest, comprising (i) direct interests in 10,190,375 Shares, (ii) deemed interests in 28,192,519 Shares held by Harrymore International Limited and (iii) deemed interests in 500,000 Shares held by Neufont. However, to avoid double counting, the deemed interest of Dr Shi Xu disclosed in this Form 3 does not take into account the deemed interest which Mdm Jin has in the 500,000 Shares held by Neufont.
