**RECEIPT OF COURT SUMMONS FILED BY A SHAREHOLDER
OF A FORMER SUBSIDIARY AGAINST YEE PINH JEREMY – REVOCATION OF CIVIL SUIT**

The board of directors ("**Board**") of Clearbridge Health Limited (the "**Company**") and together with its subsidiaries, the "**Group**") refer to the Company's announcement dated 1 June 2023 (the "**Announcement**") in relation to a civil suit (the "**Suit**") filed by PT Kreasi Putra Nusantara ("**KPN**"), the plaintiff and a shareholder of PT Indo Genesis Medika ("**IGM**"), against, among others, Mr Yee Pinh Jeremy ("**Mr Yee**") and IGM. IGM is a former subsidiary of the Group which the Group had disposed as announced by the Company on 7 October 2022 on SGXNet. Unless otherwise defined, capitalised terms in this announcement shall have the same meaning as ascribed to them in the Announcement.

The Company wishes to announce it was informed by Mr Yee on 27 September 2023 that at a hearing held on 25 September 2023, the South Jakarta District Court (the "**South Jakarta Court**") pronounced the Suit as revoked and withdrawn by KPN with immediate effect. KPN revoked and withdrew the Suit before the South Jakarta Court examined the subject matter of the Suit. The South Jakarta Court also ordered KPN to pay a court administration fee in the amount of IDR2,666,500.00 (approximately S\$235.32 based on an exchange rate of IDR11,331.47 to S\$1.00).

If there are any further developments, the Board will make such announcements as may be necessary and appropriate.
