PAYMENT OF MANAGEMENT FEE AND PERFORMANCE FEE BY WAY OF ISSUE OF UNITS IN KEPPEL INFRASTRUCTURE TRUST

Keppel Infrastructure Fund Management Pte. Ltd. ("**KIFM**" or "**KIT Trustee-Manager**"), in its capacity as trustee-manager of Keppel Infrastructure Trust ("**KIT**"), wishes to announce that 131,700 units ("**Management Fee and Performance Fee Units**") in KIT ("**Units**") have been issued today at a price of S\$0.5057 per Unit as payment of 2.4% of the aggregate of the management fee and performance fee due to the KIT Trustee-Manager for the period from 1 October 2015 to 31 December 2015.

The issue price per Management Fee and Performance Fee Unit is the volume weighted average price for a Unit for all trades done on the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") in the ordinary course of trading on the SGX-ST for the last five trading days (that is, the last five full market days when the Units are traded on the SGX-ST) of the quarter ended 31 December 2015.

The payment of the management fee and performance fee and the manner of such payment are provided for in the trust deed dated 5 January 2007, as amended, supplemented or restated from time to time, constituting KIT (the "**Trust Deed**"). It is provided in the Trust Deed that the KIT Trustee-Manager is entitled to receive its management fee and performance fee in a combination of Units and cash in such proportions as it may elect. For the period from 1 October 2015 to 31 December 2015, the KIT Trustee-Manager has elected to receive:

- (i) 2.4% of its management fee and performance fee in the form of Units; and
- (ii) 97.6% of its management fee and performance fee in cash.

As at the date of this announcement, the KIT Trustee-Manager holds 131,700 Units, representing approximately 0.003% of the total number of 3,857,063,631 issued Units in KIT.
